This event will take place on the beach behind from 104<sup>th</sup> to 107<sup>th</sup> Avenue on Treasure Island. Vendor entrance to beach located at TI Gulf Front Park, 10400 Gulf Boulevard. Snack vendors will receive a 12' by 20' space; two to four item food vendors will receive a 16' by 24' space. This will allow you to set two tents one behind another, if needed. If additional space is needed, contact Vendor Coordinator. All business/sales must be conducted within this space. **ALL VENDOR VEHICLES MUST PARK IN THE PROVIDED VENDOR PARKING AREA NO EXCEPTIONS. NO VEHICLES OR TRAILERS ARE TO BE PARKED AT VENDOR SPACES OR IN THE EVENT AREA AS STATED BELOW.** Any permits/licenses/fees are the responsibility of the vendor (see attachment for checklist and applicable fees). You must provide your own table, tent, lighting system and generators. Upon receipt of completed application and payment, the Vendor Coordinator will contact vendor and approve participation. Space assignments and parking pass will be issued upon arrival on Thursday between 9am to 12noon, only. You may leave your set-up overnight since there will be beach security Thursday through Saturday night. We are not responsible for your property. Rain or shine. **Indemnity:** The VENDOR shall defend, indemnify and hold harmless the City of Treasure Island and of the City of Treasure Island's officers, agents and employees from and against all claims, liability, loss and expense, including reasonable costs, collection expenses, attorneys' fees and court costs which may arise because of the negligence (whether active or passive), misconduct, or other fault, in whole or in part (whether joint, concurrent or contributing), of VENDOR, its officers, agents or employees in performance or non-performance of its obligation under this Agreement/Application. The VENDOR recognizes the broad nature of this indemnification and hold harmless clause, as well as the provision of a legal defense to the City of Treasure Island when necessary, and voluntarily makes this covenant and expressly acknowledges the receipt of such good and valuable consideration provided by the City of Treasure Island in support of these indemnification, legal defense and hold harmless contractual obligations in accordance with the laws of the State of Florida. This clause shall survive the termination of this Agreement/Application. Compliance with any insurance requirements required elsewhere within this Agreement/Application shall not relieve VENDOR of its liability and obligation to defend, hold harmless and indemnify the City of Treasure Island as set forth in this article of the AGREEMENT/Application. Nothing herein shall be construed to extend the City of Treasure Island's liability beyond that provided in section 768.28 Florida Statutes.

**Insurance:** VENDOR shall, at its sole cost and expense, procure and maintain throughout the term of this application, Comprehensive General Liability and Worker's Compensation insurance Employer Liability insurance to the extent and in such amounts as required and authorized by Florida law, and will provide endorsed certificates of insurance generated and executed by a licensed insurance broker, brokerage or similar licensed insurance professional evidencing such coverage, and naming the City of Treasure Island as a named, additional insured, in an amount no less than One (1) Million Dollars, as well as furnishing the City of Treasure Island with a certified copy, or copies, of said insurance policies. Certificates of insurance must accompany this Application. Nothing herein shall be construed to extend the City of Treasure Island's liability beyond that provided in section 768.28 Florida Statutes.
